Exclusive to our eligible not-for-profit customers, the **NAB Community Grants** program will award \$1 million in capacity building grants in 2016. There is flexibility around the amount we'll award per grant and per category.

Grant Category

Grant value guide

Executive Scholarship Grant

For the professional development of CEOs or nominated members of their executive leadership team. To support development initiatives that build on the core capabilities required to lead a sustainable community business. Includes, but not limited to, strategic management, governance of a not-for-profit, impact measurement or executive/team coaching.

Up to \$15,000 for an individual and up to \$50,000 for multiple members of an executive leadership team.

Impact Grant

For initiatives that seek to measure the impact of key existing programs or that seek to scale the impact of proven programs or initiatives. 'Scale' initiatives may include, but are not limited to, sharing successful intellectual property across the sector or with government.

\$30,000-\$50,000

Capacity Building Project Grant

For capacity building projects or initiatives that will support strategic growth and/or long-term sustainability of the organisation. Includes, but not limited to, establishment or growth of strategic partnerships, IT/digital projects or infrastructure upgrades that are aligned to enhanced operational efficiency or service delivery.

\$30,000-\$50,000

Eligibility Criteria

- Applicants must be a not-for-profit customer of the NAB Group of Companies as of 1 February 2016.
- Applicants must hold current Deductible Gift Recipient (DGR1) status with the ATO.
- The initiative being applied for must be delivered in Australia over the next 18 months.
- Applications will not be accepted for capital work, consolidated revenue or to conduct medical research.
- Previous recipients of either a NAB Community Grant or MLC Community Foundation Grant may apply in 2016. Previous grant recipients must meet all eligibility requirements and have submitted all acquittal requirements to date for previous grants that have been awarded.
- Applicants have the option to apply for up to two grants in total. This is limited to one Executive Scholarship Grant and one application in one other category. Applicants may only be awarded one grant in total, at the full discretion of the assessment panel.
- Executive Scholarship Grants will support courses and development initiatives delivered by reputable providers in Australia only.
