Healthy Relationship with Money

Grants will be awarded for initiatives that will meaningfully and measurably enhance the financial inclusion of disadvantaged Australians.

Individual grant value: \$50,000 (up to 5 grants available)

Total grants value: \$250,000

Women and Girls

Grants will be awarded for initiatives that will meaningfully and measurably address the unique circumstances, challenges and needs of women and girls in order for them to thrive in our communities.

Individual grant value: \$50,000 (up to 5 grants available)

Total grants value: \$250,000

Small But Strong

Grants will be awarded for localised initiatives run by small organisations building prosperous communities, promoting a healthy relationship with money or supporting women and girls.

Individual grant value: From \$5,000 - \$15,000

Total grants value: \$150,000

Eligibility criteria

- Applicants must be a not-for-profit customer of the NAB Group of Companies as of 1 February 2015
- Applicants must hold current Deductible Gift Recipient Item 1 (DGR1) status with the Australian Tax Office (ATO)
- The initiative being applied for will be delivered in Australia over the next 18 months
- Applications will not be accepted for capital work, infrastructure or consolidated revenue
- Applications will not be accepted from 2014 NAB Community Grant winners nor from organisations that have been awarded an MLC Community Foundation Grant within the last two years
- Only one application per customer/organisation will be accepted
- For the 'Small But Strong' category, revenue must have been less than \$5 million total revenue in FY13-14
